Provision of Advice


Your Responsibilities

You will be responsible for applying for vacant positions

As part of our advice, we will provide you with a list of platforms that you can use to search for vacant positions. This will be a very good start, but you need to actively look at as many job sites as possible and do you research around potential job opportunities.



Contacting employers directly can be a great way to access opportunities. When applying for roles, you will attach your Australian formatted CV and covering letter, along with the support letter from Regional Migration



Australia. Providing a professional point of contact for the business is a great way to give them access to the information they need to consider sponsoring you.

Commitment

Engagement with interested Australia employers

Employers who express interest in sponsoring you may contact us directly to discuss the requirements. We will advise obligations and documentation requirements, along with the business costs associated with sponsoring an employee.

Application Preparation
