Employer Sponsored Visa - Skills In Demand visa (subclass 482)

This visa enables employers to address labour shortages by sponsoring skilled workers where employers can't source an appropriately skilled Australian worker. This visa allows a stay up to 4 years and provides a pathway to Permanent Residency.

Core Skills Stream - This pathway is designed to cater to a broad range of skilled workers with an occupation on the Core Skills Occupation List (CSOL), and a based salary of between \$76,515 - \$141,209. You must have at least one year relevant work experience in your nominated occupation or related field

Specialist Skills Stream - This exclusive pathway targets high-earning professionals earning at least \$141,210 per year. Occupations include elite athletes, researchers and publishers. You must have at least one year relevant work experience in your nominated occupation or related field.

Labour Agreement Stream - This visa is for skilled workers nominated by employers who have a Labour Agreement with the Australian Government. Skill requirements differ, depending on the type of Labour Agreement. The key Labour Agreements are:

- Company Specific labour Agreements
- Designated Area Migration Agreements (DAMA)
- Global Talent Employer Sponsored (GTES) agreements
- Industry labour agreements
- Project agreements

Employer Sponsored Visa - Employer Nomination Scheme visa (subclass 186)

This visa allows skilled workers, who are nominated by an employer, to live and work in Australia permanently.

You can enter through a Direct Entry stream (DE), or apply via Temporary Residence Transition stream (TRT), after you have completed at least 2 years on a subclass 457 or 482 visa.

For DE you will require a valid skills assessment and at least 3 years of highly relevant experience. All work experience must be evidenced with a minimum of payslips and employer references.

You may not need a skills assessment for the TRT stream.

General Skilled Migration - Skilled Independent visa (subclass 189)

This visa is for workers with specific skills which are in high demand in Australia. It is a points-tested visa and allows the skilled worker to live and work permanently in Australia.

You do not need a sponsor, however your occupation must be on the relevant Skilled Occupation List. You will need to have a suitable skills assessment and be invited to apply for this visa.

This visa subclass is highly competitive due to having full flexibility to live and work anywhere in Australia.

General Skilled Migration - Skilled Nominated visa (subclass 190)

This visa allows nominated skilled workers to live, study and work in a nominating state or territory of Australia as a permanent resident.

Your occupation must be on the Skilled Occupation List, you must have a suitable skills assessment at the time of invitation.

You may be required to live and work in the nominating state or territory for a period of 2 years.

Regional Pathways - Skilled Work Regional visa (subclass 491)

This visa allows skilled workers and secondary applicants to live and work in regional Australia. To apply for this visa you must be nominated by a state or territory government, or an eligible relative must sponsor you.

Your occupation must be on the relevant Skilled Occupation List and you must have a suitable skills assessment at the time of invitation.

Regional Pathways - Skilled Employer Sponsored Regional visa (subclass 494)

Employer Sponsored stream

This visa allows regional employers to address labour shortages within their region by sponsoring skilled workers where an appropriately skilled Australian worker can not be found.

With this visa, the skilled worker is able to live, work and study in the designated regional area for up to 5 years. If eligible the individual can apply for permanent residency after 3 years on this visa, as long as they have met the requirements of living and working in a regional area.

For this visa you must be nominated to work in an occupation on the relevant Skilled Occupation List. You must have at least 3 years of relevant work experience. You must meet the minimum standards of English language proficiency, be under the age of 45 years, and hold a positive skills assessment at the time of making the application.

Regional visas have specific visa conditions. You must meet all visa conditions to be able to proceed to permanent residency in future.

Partner visas -

Onshore Partner visa (subclass 820/801)

This visa lets the de facto partner or spouse of an Australian citizen, permanent resident or eligible New Zealand citizen live in Australia.

Subclass 820 is a temporary visa and is the first step towards a permanent Partner visa (subclass 801).

Subclass 801 is a permanent visa and allows you to live permanently in Australia with your partner.

Partner visas -

Offshore Partner (provisional) visa (subclass 309/100)

This visa lets the de facto partner or spouse of an Australian citizen, permanent resident or eligible New Zealand citizen live in Australia. Applications for this visa must be made outside Australia.

When applying for a Partner visa you must show that you are in a genuine relationship with your spouse or de facto partner. Once this visa is approved you are able to live, work and study in Australia, and access Australia's public health care scheme. Once the permanent visa is granted you may attend free English language classes provided by the Adult Migrant English Program (if eligible).

Partner visas -

Prospective Marriage visa (subclass 300)

This visa allows you to come to Australia to marry your prospective spouse.

You must have met your prospective spouse in person and genuinely intend to live together in a mutually exclusive relationship. You must marry and subsequently apply for the partner visa within a prescribed timeframe.

You don't need to be married to apply for a partner visa. You can add your dependent children to a partner visa both during and after the temporary visa grant (but before permanent residency).
